

#### PRIVACY INFORMATION FOR SUPPLIERS

Pursuant to article 13 of UE Regulation n. 679/2016 and to the applicable privacy provisions

### **Assumption**

Pursuant to and for the purposes of EU Regulation no. 679/2016 ("**Regulations**") and any other provisions and / or legislation, national and / or Community, applicable in the matter of personal data protection, **GEM elettronica S.r.l.**, with registered office in Via Amerigo Vespucci No. 9 - 63074 San Benedetto del Tronto (AP), as Data Controller ("**Company**" or "**Controller**"), informs the supplier ("**Supplier**") that the personal data that will be provided during the establishment of the contractual relationship or otherwise acquired in the within the scope of our Company's activities, they may be processed in compliance with the following.

### 1. Purpose and legal basis of processing

The Supplier's personal data will be processed for:

- (i) purposes connected and instrumental to the execution and management of the contractual relationship with the Supplier;
- (ii) the fulfillment of legal obligations, regulations, national and / or EU regulations that may be applicable;

In these cases, the legal basis for processing the personal data of the Supplier for the above purposes is represented by the execution and management of the contractual relationship with the Supplier and by the applicable legal provisions.

- (iii) administrative accounting purposes (eg organizational, financial, internal controls, etc.), including the verification of solvency also through due diligence, consultation of public lists and / or authorized suppliers;
- (iv) the protection of the legitimate rights and interests of the Company or of third parties;
- (v) the management of litigation, in the event of breaches, disputes, judicial disputes and / or transactions.

The legal basis of the processing for the aforementioned purposes is the pursuit of a legitimate interest of the Company or a third party (eg in the case of litigation or pre-litigation), which, by virtue of the assessments made by the Company, is not detrimental to the rights of the Supplier.

#### 2. Nature of the provision of data and consequences of non-conferment

For the execution of the aforementioned purposes, the processing of the data of the Supplier is necessary and failure to provide such data will make it impossible to conclude and execute the contract between the Supplier and the Company.

# 3. Categories of subjects to whom the data may be communicated

The data of the Supplier may be communicated to customers, persons, companies, associations or professional studios that provide services or activities of assistance and advice or that provide services to the Company, with particular but not exclusive reference to accounting, administrative, legal issues, tax and financial.

The subjects belonging to the above categories will use the data as independent data controllers or managers, in the latter case duly appointed by the Company pursuant to the Rules. The list of subjects, Data Controllers or Data Processors, to whom the data may be communicated, is available upon request to the Data Controller.

Personal data may also be brought to the attention of our staff who will treat them as a processor.



# 4. Retention period

Personal data will be kept for the entire duration of the contract stipulated with the Supplier, after which they will be kept for the fulfillment of any eventual obligations connected or arising from the conclusion of the contract with the Supplier, also related to legal obligations and prescription terms for this purpose provided for by the law. We also inform you that the data may be stored for longer periods of time than the times identified in this paragraph for analysis and statistical purposes only, made anonymously and aggregated.

#### 5. Rights of the interested parties

The Supplier may exercise, in the cases expressly provided for by the Regulations, the rights referred to in articles 15 and following of the Regulations and in particular:

- (i) request confirmation that the processing of personal data is being processed and, in this case, request the Data Controller to access the information relating to the processing;
- (ii) request the correction of inaccurate or incomplete data;
- (iii) request cancellation of data;
- (iv) request the limitation of processing;
- (v) receive, in a structured format, commonly used and readable by automatic device, personal data concerning him and transmit them to another holder or obtain direct transmission from one holder to another, if technically feasible (so-called "portability of data").

The Supplier also has the right to object, in whole or in part, for legitimate reasons, to the processing of data concerning him / her.

The exercise of the aforementioned rights can be made by contacting the Data Controller in the following ways:

Finally, if the Supplier considers that the processing of the supplied data violates the legislation regarding the protection of personal data, the Supplier has the right to propose a complaint to the Guarantor for the protection of personal data (<a href="https://www.garanteprivacy.it">www.garanteprivacy.it</a>).
